



# Energy West Social Club

## School Leavers Week Agreement

The following conditions apply for the period known as "School Leavers Week". These terms & conditions are in addition to the standard Energy West Social Club Terms and Conditions which can be found at <https://energywest.com.au/assets/downloads/terms-and-conditions.pdf>

The Energy West Social Club Caretakers have been directed to be particularly vigilant during this period and will monitor all bookings accordingly.

1. Each Member booking the property **MUST** be present at the property for the entire duration of the booking (this is an existing condition of all bookings however has been reinforced within this agreement).
2. The Energy West Social Club Manager and/or the Caretaker will request tenants/persons to immediately vacate the premises, if (in their opinion) any breach of behaviour or damage to property is considered inappropriate. In the event the tenant refuses to leave the property immediately, the Police will be called. The Caretakers have been directed not to discuss the matter with tenants, simply advise the tenant to leave and refer the matter to the Energy West Social Club Manager.
3. The Member agrees that there will be no School Leavers Week parties, celebrations or gatherings will be held at the Energy West Social Club property hired by the Member.
4. The unit must not exceed 6 people staying at the property.
5. The Member consents to providing details of all person(s) staying at the property including their age and a contact mobile phone number for the primary contact (EWSC Member).
6. The Member will be responsible for any costs incurred relating to any breach notices, penalties, damages to the property and/or additional cleaning required caused as a result of their stay.
7. **Point 7 applies to those guests staying at Cape View Resort only:** As per Cape View Resort School Leavers policies, The Owners of Cape View Bungalows (strata) can request tenants/persons to immediately vacate the premises, if (in their opinion) any breach of behaviour or damage to property is considered inappropriate. The Owners of Cape View Bungalows Security will be called to vacate the persons from the property and will remain at the property until all tenants/persons leave. The Owners of Cape View Bungalows will also advise Energy West Social Club Manager should the situation arise. The cost of the security will be passed to Energy West Social Club and then passed onto the Member. The details of all person(s) staying at the property will be forwarded to The Owners of Cape View bungalows.
